**Image:** Reproductions must be full-tone black and white or full color. Except as may be expressly agreed to by CHS, image(s) may not be cropped, bled off page, reproduced on color stock nor have anything superimposed; each image must be reproduced unaltered and in its entirety on all or part of a single page. When a detail is used, the word DETAIL must appear in caption with the complete credit line.

**Credit Line:** The official credit line, as specified by CHS, must appear in one of the following locations: (a) with printed matter, it is preferred that credit line appear on the same or facing page as the reproduction; (b) with reproductions in television, films, filmstrips, videos, etc., if not stated next to the adjacent frame, credit line must appear in program credits section or in accompanying guide or manual; (c) with exhibitions, credit line must appear within the exhibition area, preferably near the image. When provided, the artist's name, title, sub-collection, donor's name, and negative number must also be included in the credit line. Incorrect, incomplete credit lines must be corrected in future reprints and/or editions. References to CHS in any manner in connection with the work, outside of copyright/credit line, are prohibited, except as may be expressly agreed to by CHS in writing.

**Reuse:** Any change in use, subsequent editions and additional language edition will be considered upon new application. CHS reserves the right to refuse permission for reuse because applicant has not met the conditions of prior agreements.

**Other:** Any breach of CHS conditions by applicant will result in revocation of permission. To the extent permitted by law, CHS reserves the right to seek remedies and/or damages. Any special conditions listed on the contract supersede any of the terms and conditions stated above.
